This Agreement, including all terms and conditions set forth herein and all Exhibits hereto, hereby incorporated by this reference, constitutes the entire agreement between Contractor and TAPAZ, and supersedes all prior and simultaneous agreements, negotiations, and representations, written, or oral. If there is any inconsistency between the terms of this Agreement and any other agreement or writing between the parties, the terms of this Agreement shall control. THE PERSON SIGNING BELOW ON BEHALF OF CONTRACTOR REPRESENTS AND WARRANTS THAT SUCH PERSON HAS READ AND AGREES TO THE TERMS AND CONDITIONS SET FORTH HEREIN, AND THAT SUCH PERSON IS AUTHORIZED TO ENTER INTO THIS AGREEMENT ON BEHALF OF CONTRACTOR AND HAS THE LEGAL ABILITY TO BIND CONTRACTOR TO THIS AGREEMENT.
